EDAM congestion revenue allocation for parallel flows

- This initiative examines congestion revenue allocation associated with day-ahead schedules impacting transmission constraints in a separate balancing area
- The ISO is planning to present a proposal for decision in June
- This additional time allows us to explore further enhancements suggested and supported by stakeholders, including consideration of:
 - Allocation of congestion revenue for OATT rights based on balanced cleared economic bids as well as self-schedules, and
 - the effects of the proposal on congestion revenue rights provided within the ISO balancing area

WEIM assistance energy transfer extension

- The ISO is proposing to extend the existing design by removing the sunset date
 - Tariff provisions currently sunset December 31, 2025
 - Decision is informed by analysis of performance
 - Ensures we retain an available tool to increase WEIM reliability
- The ISO is also proposing a minor tariff revision to ensure operator actions taken in coordination with a Reliability Coordinator do not create additional financial exposure

- Consistent with intent to increase reliability in the WEIM

• Proposed decisional classification: Joint authority

Price formation enhancements initiative

- Planned stakeholder working group meetings have been adjusted to accommodate other initiatives
 - Long term prioritization of scarcity pricing, market power mitigation at the balancing area level and fast start pricing have been assessed through stakeholder survey
- Market power mitigation analysis presented at the Market Surveillance Committee meeting
- Internally developing straw proposal for scarcity pricing and market power mitigation at the balancing area level; publication expected Q2 2025

Greenhouse gas coordination working group

- Working group has been focused on accounting for state policies without a price on carbon emissions
- Designing policy on an out-of-market "accounting and reporting" approach
- A sub-group and the working group are developing the report format
- We are planning to publish a straw proposal in Q2 2025
- Tariff authority may be needed to outline the funding approach
- Proposed decisional classification: Joint authority



Gas resource management initiative

- ISO staff developing a straw proposal informed by stakeholder comments and preferred prioritization; expected Q2 2025 publication
- Stakeholders indicated a preference to focus on enhancing advisory gas burn information in advance of the extended day-ahead market, exploring exceptional circumstance cost recovery, and ISO coordination with gas pipelines during restrictive operating conditions
 - Some of these changes would be process enhancements, whereas others may require tariff changes.
- Proposed decisional classification: Joint authority

Congestion revenue rights

- The congestion revenue rights working group has discussed:
 - The current program structure and function for stakeholders
 - ISO's root cause analysis on the 2018 reforms
 - Benchmarking other ISO/RTO's financial transmission right models
- As part of the 2018 reforms designed to resolve observed inefficiencies with the auction, the ISO committed to:
 - Assess the impacts of the proposals
 - Consider more comprehensive changes to the allocation and auction design
- Proposed decisional classification: TBD



Demand and distributed energy market integration

- The working group is exploring the development or enhancement of participation models and market rules associated with demand response and distributed energy resource participation
 - Discussion paper: organizes stakeholder feedback and assists with policy prioritization
 - Six topics were identified within which problem statements have been drafted for stakeholder examination and refinement
 - Latest working group examined the first of those topics: performance evaluation methodologies, including recognition of registration and metering alternatives
- Proposed decisional classification: TBD



Storage design and modeling

- The ISO hosted monthly stakeholder meetings including discussions on stakeholder-requested topic overviews
 - Stakeholders such as Vistra, PG&E, and Terra-Gen have presented on topics including outage management, novel participation pathways, and hybrid resources
- The ISO released the issue paper and straw proposal on outage management, nonlinearity, and state-of-charge clarification topics
- The ISO is planning to update the state-of-charge formula to ensure availability of flexible ramp up from storage resources
- Proposed decisional classification: TBD



Policy initiatives catalog & roadmap process

- Stakeholders submitted discretionary policy initiative proposals to the ISO during February 2025
- Stakeholder prioritization workshops & Regional Issues Forum Roundtable: April 2025
- Stakeholder prioritization & ranking survey: May 2025
- 2025 Roadmap updates
 - Present revised 2025 Roadmap May 21 Joint WEM
 Governing Body and ISO Board of Governor meeting
 - Goal: update schedules for existing policy initiatives to accommodate stakeholder bandwidth

The working group is progressing toward straw proposals.


Track 1: Modeling & Default Standards

- · Loss of load expectation modeling
- Updating ISO default planning reserve margin and default counting rules
- Unforced capacity in collaboration with the CPUC and other local regulatory authorities
- Accounting for ambient derates due to temperature for resource adequacy resources
- Track 2: Outage and Substitution & Availability and Performance Incentives
- Updating the ISO's outage and substitution processes
- Reforming availability and performance incentives

Track 3: Visibility and Backstop Reform

- · Increase the ISO's visibility into available backstop capacity
- · Increase transparency to stakeholders on backstop decision making
- Update the current backstop product
- Create longer-term solutions for the ISO balancing authority area around curing deficiencies and assigning costs related to the EDAM resource sufficiency evaluation
