#### DISCUSSION OF ISSUES AND TOPICS IN THE JULY 31<sup>ST</sup> STRAW PROPOSAL

Committee Chair Hampton provided an overview of the agenda for the general session noting that there would be opportunities for public comment after each topics and issue updates by the working groups. She provided an overview of the timeline and stated the draft final proposal was on track for completion in Q1 2021.

The delegation of authority working group provided an overview of its continued work in refining its recommendations related to governance for market design rules. The following stakeholders provided feedback to the EIM Governance Review Committee and discussion ensued amongst the presenters and committee members: Alaine Ginocchio (Western Interstate Energy Board), and Joseph Abhulimen (CPUC – Public Advocates Office).

The stakeholder engagement working group provided an overview of its continued work in exploring enhancements to its recommendations for the EIM Governing Body and stakeholder engagement. There was no public comment.

The other areas of involvement working group provided an overview of its continued work in contemplating guidelines for an outside market expert and on the proposal made by AWEA regarding review of the open access transmission tariffs of EIM/EDAM entities for consistency. The following stakeholders provided feedback to the EIM Governance Review Committee and discussion ensued amongst the presenters and committee members: Caitlin Liotiris (AWEA), Clay MacArthur (Deseret Power), and Anita Decker (EIM Governing Body).

Committee Chair Hampton concluded by summarizing the GRC's next steps noting the draft final proposal was on track for Q1 2021.
