# **DECISION ON GENERAL SESSION MINUTES**

Committee member Tony Braun moved for approval of the November 7, 2022 Governance Review Committee general session minutes. Committee member Jeff Nelson seconded the motion and voting members approved the minutes, 10-0.

## PRESENTATION ON EDAM GOVERNANCE REVISED DRAFT FINAL PROPOSAL

Governance Review Committee (GRC) Vice Chair Rebecca Wagner started the meeting by acknowledging the contributions of past and present GRC members. She then noted the special dedication in the proposal honoring former GRC Chair Therese Hampton. Next, Vice Chair Wagner provided an overview of upcoming stakeholder engagement activities leading up to presenting the proposal for decision to the WEIM Governing Body and ISO Board of Governors during their joint general session meeting on February 1, 2023.

Next, Committee member Letha Tawney presented the GRC's recommended changes to the delegation of authority proposal, which included a discussion on the type, decisional classification, dispute resolution, and scope of authority in alignment with the organizing principals.

Next, Committee member Suzanne Cooper provided an overview of the GRC's recommendations with regard to the WEIM Governing Body, including the size, process for selecting members, and compensation. Member Cooper then presented the GRC's proposal regarding stakeholder engagement and the policy development process, which included recommendations on the Regional Issues Forum's role and EDAM sector representation.

Next, Committee member Eric Eisenman presented the GRC's recommended amendments to the ISO Bylaws.

Finally, Vice Chair Wagner reviewed the GRC's recommendations for approval of policy and timing of implementation of the governance changes.
