# GENERAL SESSION MINUTES MARKET SURVEILLANCE COMMITTEE MEETING September 8, 2014 Teleconference Meeting

# September 8, 2014

The Market Surveillance Committee (MSC), an advisory committee to the ISO Board of Governors, convened the general session at approximately 2:00 p.m. via teleconference and the presence of a quorum was established via roll call.

# **PUBLIC COMMENT**

No public comment was offered at this time.

## DRAFT OPINION ON COMMITMENT COST ENHANCEMENTS

Dr. Hobbs summarized the main elements of the draft opinion on commitment cost enhancements. He explained that the MSC was asked to comment on the proposed enhancements to the procedures used to calculate start-up and minimum-load costs for electricity generators. Dr. Hobbs further explained the proposal for calculating commitment costs is reasonable from the stand-point of what can be implemented prior to this coming winter.

Dr. Hobbs stated the MSC encouraged the ISO's goal of developing, testing, and implementing an opportunity cost calculation methodology for use-limited natural gas units prior to the summer of 2015, if possible or as soon as feasible thereafter.

Dr. Hobbs further explained that, as a temporary expedient, allowing limited-use units a registered cost option based on 150% of the projected average proxy cost is an acceptable means of providing flexibility in the near term prior to implementation of the opportunity cost estimation methodology. However, the he stated that the MSC suggested an alternative approach outlined in their opinion that in their view offers some advantages over the proposed temporary fix.

Dr. Hobbs confirmed there was no comment from the MSC members.

Dr. Hobbs confirmed there was no public comment at this time.

Dr. Bushnell:

Moved, that the Market Surveillance Committee, an Advisory Committee to the Board of Governors of the California Independent System Operator Corporation, adopt the draft opinion titled "Opinion on Commitment Cost Enhancements"

The motion to adopt the draft opinion was seconded by Committee member Dr. Oren, and approved 4-0-0, via roll call.
