Dear ISO Board of Governors and EIM Governing Body,

It is with sincere interest in the success of EIM and the enhancement of the Western EIM governance structure that I submit this Statement of Interest to be considered for membership on the EIM Governance Review Committee (GRC). Specifically, I am putting forth my interest to serve as a membership nominee from the "Pending New EIM Participants Sector." This sector includes any Balancing Authority that has entered into a formal public process to consider joining EIM – as Bonneville Power Administration (Bonneville) has done – and any publicly-owned utility, other load-serving entity, or supplier of generation within such a balancing authority that may participate in EIM if the balancing authority becomes an EIM Entity. I have also been nominated by the "Publicly-Owned Utility Sector".

This opportunity for membership on the GRC is of major importance to Bonneville, its customers, and its stakeholders. I am pleased to highlight that my participation will be supported fully by the agency, not only through the latitude I have been given to dedicate my time and effort to the GRC process and to engage in the process from the broadest public benefits perspective, but also through the commitment of resources to assist me for the duration of the GRC.

My participation on the GRC will bring a diverse perspective to this process in that Bonneville has a:

- Primary customer base of public power across eight Western states, with a significant amount of that load in EIM Entity Balancing Authorities that has given the agency deep insight into EIM operations and commercial transmission service from the EIM Entities since before the launch of the EIM in November 2014;
- Diverse customer base of Marketers, Independent Power Producers, Investor-Owned Utilities, and Federal Agencies;

- High-voltage transmission system that connects to 17 Balancing Authorities across the Pacific Northwest, including Canada and California, that is also used to facilitate EIM Transfers;
- Large, flexible, carbon-free hydro generation fleet; and
- Is a large federal agency whose staff is respected for its expertise in the commercial and operational areas necessary to further the success of EIM and enhancements to its governance.

I have been with Bonneville for 28 years, with a career that includes roles leading multi-party efforts on complex issues such as power marketing in bilateral and organized markets, power rate making, and hydropower system operations to preserve fish populations. As the Vice President of Bulk Marketing since to 2011, I have been responsible for marketing, sales, scheduling and account servicing for bulk power markets (non-preference, market-based services). This includes managing wholesale bulk marketing sales, making long term purchases up to 5 years in the future, managing BPA transmission purchases for surplus marketing, and engaging in market policy initiatives. During my tenure, my staff and I have also been active participants in each recent market formation effort that Bonneville has engaged in, providing me with broad understanding of organized markets and their governance.

Additionally, I have been an active participant in regional and California governance framework dialogue—from the broad western region-wide discussions that contemplated possible benefits of creating a regional power grid operator among western states, to my membership on the Western EIM Regional Issues Forum (RIF) since its inception. I currently serve as Secretary to the RIF.

I look forward to the opportunity to serve on the GRC, if given the privilege to do so. Thank you for your consideration.
