On December 13, 2019, the California Independent System Operator Corporation (CAISO) filed an Energy Imbalance Market (EIM) Implementation Agreement (Agreement) with Tucson Electric Power Company (Tucson). The Agreement sets the terms under which CAISO will extend its real-time energy market systems to provide imbalance energy services to Tucson pursuant to CAISO's EIM tariff provisions. Under the Agreement, Tucson will compensate CAISO for its share of the costs of related system changes, software licenses, and other configuration activities. The Implementation Agreement is accepted for filing, effective April 1, 2020, as requested.

This filing was noticed on December 13, 2019, with comments, protests, or motions to intervene due on or before January 3, 2020. No protests or adverse comments were filed. Notices of intervention and unopposed timely filed motions to intervene were granted pursuant to the operation of Rule 214 of the Commission's Rules of Practice and Procedure (18 C.F.R. § 385.214). Any opposed or untimely filed motion to intervene is governed by the provisions of Rule 214.

This action does not constitute approval of any service, rate, charge, classification, or any rule, regulation, contract, or practice affecting such rate or service provided in the filed documents; nor shall such action be deemed as recognition of any claimed right.
