# AB 825: California Unlocks the Door to West-Wide Grid Governance

Signed into Law (September 2025) – Key Provisions

- Authorizes New Governance: CAISO & California utilities can join voluntary, Westwide wholesale electricity markets (e.g., EDAM) overseen by a new, independent regional organization (RO)
- Preserves State Authority: CAISO stays as Balancing Authority & transmission planner; California agencies (CPUC, others) retain control over procurement, reliability, and planning
- Protects Climate Goals: California required to be authorized to track and enforce its greenhouse gas (GHG) policies (e.g., cap-and-trade)
- Right to Withdraw: California, like any other state, can exit the regional market if it's no longer in the state's interest

#### **Independent Board**

#### **Organizational:**

- · Independent RO Board
- · Sole authority over BPMs
- Separate & independent legal entity
- Regular evaluations of CAISO contract performance
- Joint Reporting from Independent Market Monitor
- Ability to add voluntary market services for Western entities who request them

#### Tariff:

- · Sole 205 Filing Rights
- Sole authority over provisions related to WEIM and EDAM

#### Staffing:

- · RO dedicated staff
- Advisory input into VP selections that oversee market policies
  - Advisory role in selection of CAISO CEO and management level staff

#### **Stakeholder Process & Public Interest:**

- ·RO led, CAISO supported stakeholder process
  - Body of State Regulators
- Independent Consumer Advocate Organization
  - RO Office of Public Participation



#### **Structural Recommendations**

- RO Launch: Option 2.0
  - Policy-setting organization for the establishment and oversight of market rules for the WEIM and EDAM
- Over time, consider transition to Option 2.5
  - Feasibility study by the RO Board and stakeholders to assess costs, benefits, possible expanded market functions, and implementation details
  - Determine future structure needs to enable continued evolution
- Long-term Vision: The RO will be able to offer, on a voluntary basis, any additional services desired by Western stakeholders.
  - While some utilities may not have the regulatory authority at the outset to participate in this broader menu of services, opportunities exist to gain many of the benefits of broad participation in the RO services through co-optimization of the RO's new services under a vendor contract with the CAISO.

## **SRC** Role, Responsibilities, and Expectations

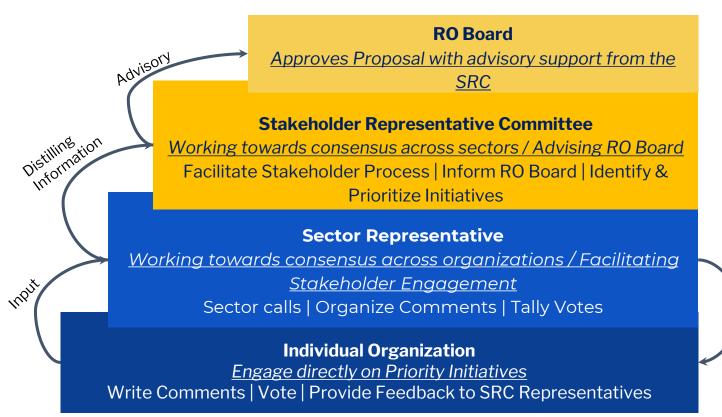
**Role**: provide advice, input, facilitate and support the participation of stakeholders in the stakeholder process, both individually and at the sector level.

**Responsibilities**: primarily responsible for delineating any guidelines and procedures for the conduct of SRC activities in the RO stakeholder initiative process.

**Expectations**: commitment to supporting and facilitating the participation of the stakeholder community even if a given stakeholder's perspective or position does not necessarily align with the position of the SRC representative, the position of the representative's company, or the position of the representative's sector. *Expected participation in at least 80% of the meetings*.

#### Stage One: Issue Evaluation

- SRC identifies sponsors to work with all stakeholders
- Working groups form around catalog issues
- Initial initiative idea becomes discrete problem statement

Refined problem statement moves to Stage Two

#### Stage Two: Policy Development

- Small ad hoc working groups develop under SRC oversight
- SRC may develop standing committees
- Work group helps RO staff weigh stakeholder input
- Problem statement becomes final proposal, after at least one stakeholder meeting and comment period
- RO staff develops the final proposal and SRC votes before it moves to the RO Board.

Final Proposal Moves to RO Board





## **Voting**

- Advisory voting at the individual entity level
- Voting will occur periodically:
  - Policy Roadmap process (approval of final Roadmap)
  - Various points during work group and initiative phases (problem statement/scope definition, straw proposal/revised straw proposal, final proposal)
- Remand process: if "significant opposition" exists, stakeholders will rework a proposal to address concerns and to achieve broader support
  - Would apply to final proposals prior to an initiative being sent to the RO Board
- Tabulated reporting of all underlying votes available to the RO Board and the public (geography, sector, line of business, supply and load, etc.)







## **Launch Committee Mission**

The Mission of the Launch Committee of the WWGPI (Committee) is to develop and form a new and independent entity with an independent governance structure that is capable of overseeing an expansive suite of West-wide wholesale electricity markets and related functions based on the following core principles:

- The entity should enable the largest footprint possible that includes California, and maximizes overall consumer benefits;
- The entity will include independent governance for all market operations;
- The new entity will preserve and build upon existing CAISO market structures that serve over 80% of the Western Interconnection, including the Western Energy Imbalance Market (WEIM) and the Extended Day Ahead Market (EDAM);
- A primary goal will be to minimize duplication and incurrence of costs for both the market operator and market participants; and
- The structure should be flexible to accommodate the future voluntary provisions of full regional transmission organization (RTO) services for those entities that desire to do so, but not mandate that any entity must join such a future potential RTO.



## **Evaluation Criteria**

- 1. **Maximized net benefits**, including reliability, affordability and environmental benefits, recognizing startup and ongoing costs, and considering both new benefits and impacts on existing benefits.
- 2. **Equitable representation** across the Western region and among all market participants, including for a wide range of legal entities.
- 3. **A governance structure** independent of any single state, participant, or class of participants.
- 4. **Organizational flexibility** to accommodate future expansion of regional solutions and to create a credible and timely path to a voluntary RTO, including the balancing authority and transmission planning functions.
- 5. **Optionality** to allow market participants to choose the market services they value.
- 6. **Preservation** of existing balancing authorities' ability to maintain independence, authority, and governance.
- 7. An implementation timeline that promotes broad market participation.
- 8. **Respect for state authority** to set procurement, environmental, reliability and other public interest policies.

## **RO Scope and Function**

#### **Under Option 2.0**

- RO full governance authority over WEIM/EDAM market rules, with sole Section 205 rights
- Single integrated tariff, with process to organize CAISO tariff into sole RO, sole CAISO, or shared authority
- Market operations continue to be performed and overseen by the CAISO
- CAISO will remain the counterparty to existing market contracts
- CAISO staff will retain emergency operational authority
- Initial estimated annual cost of \$1.25 to \$1.5 million, increasing to \$10 to \$14 million as organization develops.



## **RO Scope and Function**

#### **Under Option 2.5**

- RO full governance authority over WEIM/EDAM market rules with ultimate responsibility for operation of the market; sole Section 205 rights
- Possible separation of the RO tariff from CAISO tariff
- CAISO's financial responsibility, liability, and compliance shifts to the RO
- CAISO continues market operation under a vendor contract with the RO
- RO will likely become a public utility
- RO will likely become counterparty to existing CAISO market contracts
- Estimated annual cost of \$25 million- RO will have more extensive staffing



### **RO** Formation

- 501(c)(3) nonprofit corporation
  - Tax exempt status to lower costs and the ability to utilize taxexempt financing for long term debt.
  - Operates for the public benefit and is prohibited from lobbying and engaging in political activities.
- Incorporated in Delaware
  - Well-developed body of corporate law, knowledgeable judges, and permissive rather than prescriptive corporate formation and operation.
- Principal Place of Business TBD by RO Board
  - Strong consideration to Folsom, CA to capitalize on the benefits of locating near the Market Operator.
  - Board meetings would rotate among the market-participating states



#### **RO** Governance

- Independent seven-member Board that exercises sole authority over the WEIM and the EDAM
- No reserved seats, no restriction on the number of current WEM Governing Body members serving on RO Board - interested members will move directly to Nomination Process
- RO Board Public Policy Committee
- Open process for meetings/decision making
- RO Board and CAISO Board have collaborative relationship; joint meetings for joint authority matters, each Board meets separately for sole authority issues

# RIF Enhancements Project

# Enact aspects of Pathways Step 2 SRC recommendations and prepare the RIF to transition to the SRC

- Near-term RIF Enhancements
  - Greater Policy Roadmap engagement
  - Stakeholder sponsor pilot program
  - Indicative voting

Should not require changes to the WEM
Charter

- Facilitate transition of the RIF into the SRC
  - Identify actions needed for full SRC activities
  - Prepare for sector expansion and realignment

Will require support from Pathways, CAISO, stakeholders, and WEM Governing Body

### Near Term Enhancements – Overview

- Enhanced role in the Policy Initiatives Catalog and Roadmap.
   Maintain existing "roundtable" plus:
  - Coordination with CAISO staff on roadmap decisions
  - Sector level voting on final Catalog and Roadmap
- Sector sponsor pilot program
  - Identify a stakeholder initiative
  - At least two sponsors to guide problem statements, policy, and communication
- Indicative voting
  - Add on to existing comment process
  - Aggregate results by sector
  - Formalize process for comments to WEM GB
- Maintain educational role

# Policy Initiatives Identification and Prioritization – Draft Final Proposal

- Currently, the RIF is engaged in the annual prioritization process for the Policy Initiatives Catalog/Roadmap
  - Annual roundtable discussion and report
- Draft Final Proposal includes key enhancements to advisory role
  - Consultation with CAISO staff on Catalog and Roadmap development
  - Coordinate with CAISO staff on Roadmap prioritization and documentation of rationale for prioritization decisions
  - Establish communications for mid-stream prioritization changes
- Consideration of indicative voting on final Catalog/Roadmap documents
- Implementation will be phased to manage concerns of expanded workload

# Sector Sponsorship – Draft Final Proposal

### Purpose

- Facilitate engagement among stakeholders and assist with outreach between stakeholders and CAISO staff
- Help ensure the initiative is progressing in a constructive manner, that stakeholder voices (both majority and minority) are considered, and facilitate substantive discussions among stakeholder with differing perspectives
- Sponsors would not need to be RIF liaison or SRC representative
  - Sponsor should understand issues and have interest in facilitating stakeholder engagement, but does not need to be a technical expert
  - Sponsor would be expected to separate their facilitation role as a sponsor from their advocacy role for their company

### Sector Sponsorship – Draft Final Proposal

#### RIF proposal

- Select initiative from the 2025 Policy Roadmap to pilot sector sponsor role
- Goal to further refine responsibilities and functions of the sponsor

#### Initial guidelines

- Sponsor to limit advocacy while performing role
  - Sponsor will still participate in the stakeholder process on behalf of their company
- RIF will start with at least two sponsors for the initiative
  - Spread out the workload and provide CAISO staff with diverse perspectives
- Sponsors will provide updates to stakeholders and the RIF to provide transparency to the role

#### Process

- RIF liaisons will solicit interested volunteers within their sectors
- RIF will collaborate closely with sponsors, CAISO, and Pathways during the pilot
  - RIF wants to ensure the sponsor role is aligned with Pathways Step 2's purpose while also ensuring the sponsor role provides value to the stakeholder process

## **Indicative Voting**



#### Indicative Voting Proposal – Draft Final Proposal

- CAISO begin implementing indicative voting during each comment period within the stakeholder process
  - Addition to the comment process, not a replacement of the current process
- Stakeholders should have a choice to provide only a vote or to include comments to further explain the position
- Following stakeholder feedback:
  - Include additional voting options of support with caveats and oppose with caveats
- Report the indicative voting by sector to the WEM Governing Body along with a summary of stakeholder feedback to indicate nuanced comments

## Function and Purpose of the RIF – Draft Final Proposal

- Discussion Paper focused on whether to evolve the role of the RIF toward a more active advisory function
  - Whether to retain or adjust educational role
- Draft Final Proposal
  - Reaffirms the RIF's commitment to serve as a forum for education and discussion of western market issues
  - Proposes continuing work with stakeholders to develop process for RIF comments on active initiatives, including guidance regarding the topics RIF may address
    - Likely entails enhanced sector coordination
    - Will evolve over time
- Feedback request
  - Stakeholder perspectives on RIF's role and process for providing comments on behalf of the RIF



#### RIF-to-SRC Transition and Sector Evolution



#### SRC Transition – Draft Final Proposal

- The RIF proposes to move forward with development of a transition process—in collaboration with Pathways—to transition the RIF into the SRC
  - Timing and implementation approach need to be determined
  - Maintain existing functions of the RIF
- Close coordination with Pathways is essential
  - RIF and Pathways will each need to evaluate transition process that is workable for both sides
  - RIF objective is to support RO process while assuring continuing RIF independence until transition is implemented
- RIF will ensure Governing Body is briefed on status and process elements
- Collaboration with CAISO also key to successful transition process



### Sector Transitions – Draft Final Proposal

- For newly formed sectors under the SRC, proposal is to support sector readiness
  - Identify contact leads for new sectors to facilitate SRC sector formation
  - New sectors not created under RO/SRC is stood up
- For existing RIF members that will be impacted by sector changes, proposal is to ensure awareness
  - PIO/Consumer Advocates, ISO PTO, and PMA sectors
- Timing of changes to be determined through coordination with Pathways but likely closer to SRC formation

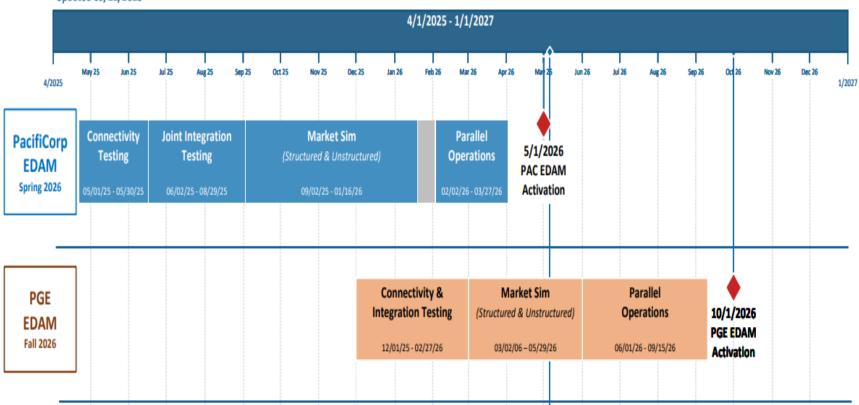

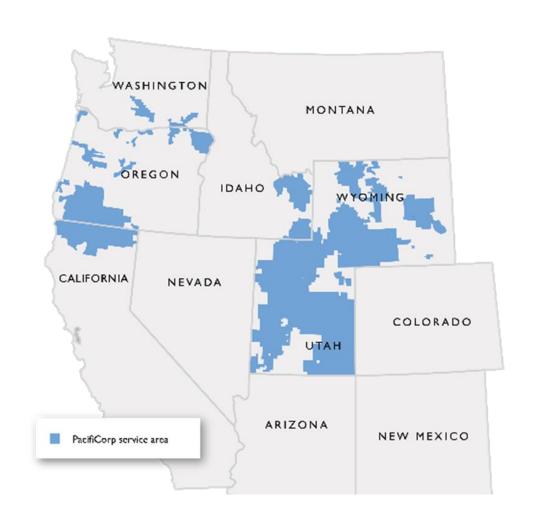




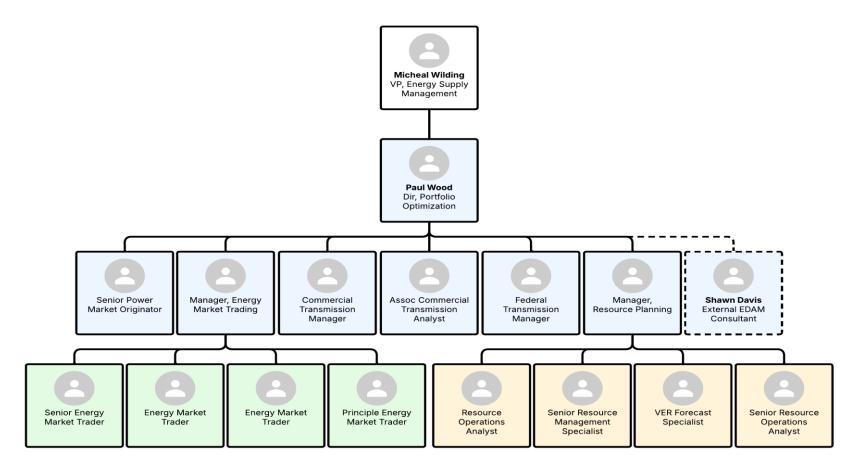


#### PacifiCorp's System Overview

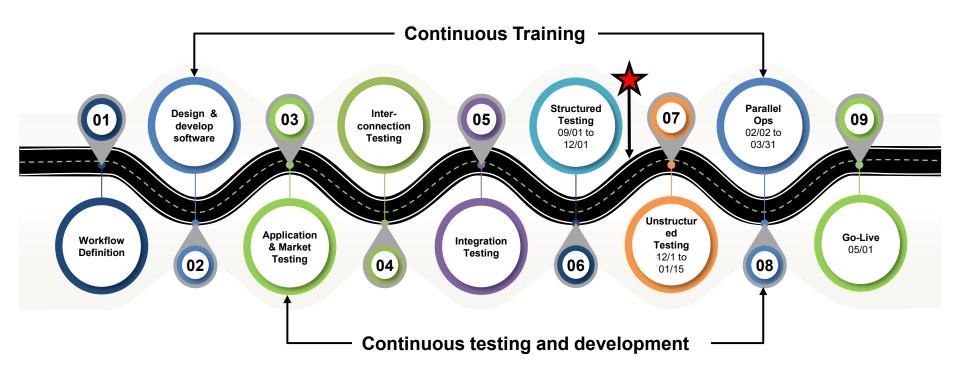
- PacifiCorp serves 2.1 million customers across six states
- PacifiCorp consists of two balancing authority areas
- 66,000 miles of distribution lines
- 17,000 miles of transmission lines
- 12,685 MW peak demand load for combined BAs
- 72 generating units: thermal, hydro, wind, & solar
- PacifiCorp Energy Supply Management acts as an independent SC



## **EDAM SC Org Chart**



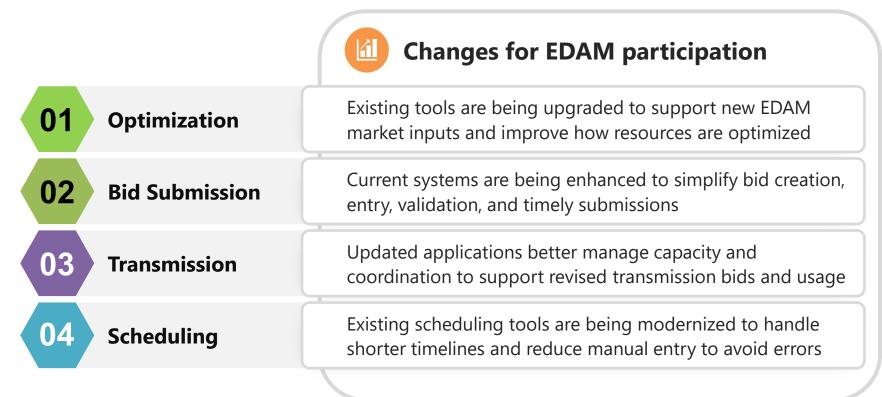
#### **EDAM Implementation Progress**

- Typical market and SC application development coordination challenges to be overcome prior to participation

### **EDAM Application Updates**



#### **Change Summary**

- EDAM products and requirements need major software updates, with communication across vendors, platforms and CAISO applications
- The updates focus on faster performance, streamlined workflows, and greater efficiency



#### INTEGRATION

Apply everything in real "Day in the Life" through vendor onsite training and scenarios



**EDAM** 

#### **APPLICATION**

Practice skills in structured and unstructured testing



#### ACTIVATION

Connect EDAM computer based and instructor lead training to past market and tagging experience

- Training is ongoing and built around how the scheduling coordinator uses the new tools and market functions
- Scheduling coordinator section leads become the go-to experts to keep that knowledge in-house after go-live
- Scheduling coordinator vendor and end-to-end workflow training sessions lined up right before parallel operations and go-live

### **Historic Experience and Advice**

- We're keeping energy and gas trading, resource Planning and transmission aligned to cut down on rework
- Getting vendors and consultants involved early helps clear up assumptions before they become problems
- Strong documentation and gap review keeps implementation on track
- We treat testing as hands-on training it's how teams build confidence before go-live
- Flexibility is key market rules and designs will shift
- Investing in training and expert support pays for itself through a smoother rollout
