#### **DECISION ON GENERAL SESSION MINUTES**

Committee member Taylor moved for approval of the EIM Governance Review Committee general session minutes for the August 7, 2020 meeting. The motion was seconded by Committee member Braun and approved 12-0.

## DISCUSSION OF STAKEHOLDER COMMENTS ON THE WESTERN EIM GOVERNANCE REVIEW COMMITTEE'S DRAFT STRAW PROPOSAL

Committee Chair Hampton described how the EIM Governance Review Committee members sought stakeholder feedback on their proposed recommendations in the July 31, 2020 straw proposal. She stated 19 sets of comments had been received with most generally supportive of the proposal. She stated the GRC identified six broad governance related issues.

#### Public comment

Alaine Ginocchio, on behalf of the Western Interstate Energy Board, provided public comments concerning the number of EIM Governance Review Committee meetings held in executive session as opposed to general session. Brief discussion followed and Roger Collanton, Vice President – General Counsel, provided responsive comments as related to the ISO's Open Meeting Policy.

Committee Chair Hampton concluded by summarizing the GRC's next steps noting that a revised straw proposal was on track for Q4 and submittal of the draft final proposal in Q1 2021. She stated the GRC would assess if additional governance changes were needed prior to final approval of the extended day-ahead market design.
