GENERAL SESSION

The following agenda items were discussed in general session:

PUBLIC COMMENT

DECISION ON GENERAL SESSION MINUTES

Committee member Sporborg moved for approval of the WEIM Governance Review Committee general session minutes for the February 17, 2022, meeting. The motion was seconded by Committee member Eisenman and approved 11-0.



PRESENTATION ON EDAM GOVERNANCE REVIEW

Milos Bosanac, Regional Markets Sector Manager, Market and Infrastructure Policy, provided an overview of a graph that depicted the EDAM development and implementation timeline with a projected 2024 go-live date. He stated that three stakeholder working groups were launched on January 3, 2022, and concluded on March 17, 2022. Next, the following individuals provided updates on activities by their respective working groups: Bobby Olsen, Director, Supply & Trading and Fuels, Salt River Project (Working group 1: Supply commitment & resource sufficiency evaluation); Kevin Smith, Attorney, Braun, Blaising, Smith and Wynne, Balancing Authority of Northern California (Working group 2: Transmission commitment & congestion rent allocation); and, Mary Wiencke, Executive Director, Public Generating Pool (Working group 3: Greenhouse gas accounting and costs). Mr. Bosanac concluded the presentation by reviewing next steps on the straw proposal.

Next, Therese Hampton, Chair of the WEIM GRC, provided a high-level overview of stakeholder comments received in response to the four questions posed by the WEIM Governance Review Committee (GRC) on the extended day-ahead market design. Ms. Hampton noted the comments were consistent in supporting the evaluation of governance and market design in parallel and next provided a high-level overview of process recommendations. Ms. Hampton stated the WEIM GRC has developed subgroups to further evaluate the stakeholder comments and concluded by reviewing the WEIM GRC's governance review timeline, noting the next general session was scheduled for April 29, 2022. Brief discussion followed.
